Hazardous Wastewater Disposal	76121904	Disposal of hazardous wastewater resulting from the use of water in a manufacturing process e.g. slop oil/oily water removal
Arc Welding Services	73181901	Fabrication, repair, maintenance, and joining of metal components, structures, piping, and equipment using electric arc welding processes. Services may include surface preparation, fit-up, welding, inspection support, grinding/finishing, and compliance with applicable safety and quality standards
Machining Services	73181024	Machining is the process used to remove material, typically metal, to create parts for machines, tools, transportation, and more. Machine shops and machinists use equipment like lathes, mills, and drill presses to turn material into useful tools using precise cut.
Motor installation and maintenance service	72154302	Installation, repair and maintenance of motors
Valve maintenance and repair service	72154105	Inspection, overhauling, testing, repair, fabric maintenance, lapping, seat replacement, gland packing replacement, actuator servicing, control valve calibration, stroke testing, PSV removal and recertification, leak rectification, diagnostics, and emergency valve change-out.

High voltage overhead line maintenance and repair	81102402	High voltage overhead line maintenance and repair
Rescue service teams	92101901	Standby rescue coverage for confined space entry, work at height, hot work, and high-risk maintenance activities; emergency response support; rescue equipment provision; stretcher and retrieval system support; and trained personnel for rapid response during shutdowns, turnarounds, and major maintenance activities.
